## ABOUT THE FOUNDATION



### MEDORA

The Theodore Roosevelt Medora Foundation (TRMF) is a public non-profit organization that was formed in 1986 by a multi-million dollar gift from Harold Schafer and his family – most famously known as the founders of the Gold Seal Company, the maker of Mr. Bubble, Glass Wax, and other nationally-known household products.

For Harold and his wife Sheila, the beauty and history of Medora and the Badlands was just too much to let disappear with the sands of time – so he made it his life's work to save it for generations to come. He began his labor of love in 1962 with the renovation of the Rough Riders Hotel and, in 1965, revitalized what we know today as the Medora Musical.

Harold continued giving to the historic cow town frequented by Theodore Roosevelt, the Marquis de Mores, and many-a rough-and-tumble westerner until his passing in 2001.

Today, we at TRMF strive to accomplish our mission to preserve, present, and serve all that Harold loved about Medora by operating history, education, and entertainment businesses that allow the traveling public to fully enjoy the beautiful North Dakota Badlands.

Through the contributions and teamwork of a Board of Directors, a full time staff of 45, 300 seasonal employees, over 500 seasonal volunteers, and financial backing from generous supporters, TRMF connects people to Medora for positive, life-changing experiences.

# THE AWARDS

## BULLY SPIRIT AWARD HONOREE FRANK LARSON

The Theodore Roosevelt Medora Foundation Board of Directors recently selected Frank Larson to receive the Bully Spirit Award.

The selection process is rigorous as we only recognize one person per year and Frank is just the second recipient of this award. As you read the description of the award below, you will see clearly, why Frank was chosen.

Just as people are attracted to Medora for varied reasons, Bully Spirit Award recipients will be known for their extraordinary efforts to share the history of Medora, Harold Schafer, and Theodore Roosevelt; their impact through volunteerism; their generosity; their care for the landscape; their optimism which fuels action and achievement; and their extraordinary positive impact on the greater world in which they live.

Frank served on our board of directors for twelve years and was the chairperson for seven of those years. Those were transformative years for Medora and TRMF – a Historic Preservation and Restoration Board Committee

was formed, and that drove the improved condition of many of our properties. It is hard to imagine Medora today without Bully Pulpit Golf Course or the Rough Riders Hotel; it is even harder to imagine those projects without Frank’s leadership and support.

Frank has had a tremendous impact on the appearance of Medora. However, it is what we all learned from Frank that has meant the most to us. We learned: that a smile is easy; a word of encouragement is easy; belief in others goes a long way; there is magic in the words “do you think we can……”; to thank people when someone leaves your organization and see it as an opportunity to get stronger; to dream bigger; and we learned that Frank truly valued Medora and what it means to the state of North Dakota.

TRMF President Randy Hatzenbuhler said, “Frank is one of the most remarkable people I have met and I am grateful for his friendship.”

Congratulations to Frank Larson, our 2019 Bully Spirit Award recipient. It is an honor well-deserved.

The scholarships, ranging from \$1,000 to \$1,500, are awarded annually through the Tjaden Education Assistance Program, named after the late TRMF President, Rod Tjaden. Scholarships go to employees currently pursuing undergraduate degrees. The ten, \$500 TRMF ambassador awards are given to graduate students or non-college student TRMF employees.

Scholarships are available to TRMF employees who are currently pursuing an undergraduate degree to receive scholarships. Scholarship and award winners need to demonstrate outstanding leadership and have a positive influence on the city of Medora, visitors of Medora, and their fellow employees.

Van and Dee Larson Ambassador Awards honor eight outstanding TRMF employees that have left an indelible impression on Medora.

In order to be eligible for scholarships and ambassador awards, applicants must work at least 480 hours during the summer season. Employees who have shown excellent leadership skills throughout the summer season can be nominated by a manager, a coworker, or can nominate themselves. Scholarship and ambassador award recipients are then selected by a special committee that is appointed by TRMF President, Randy Hatzenbuhler.

My dad, Harold, created today's Medora as a family-friendly entertainment and recreation center that is comfortable, relaxing and fun! park responds to people's comments about having more for young people to do while in Medora and was designed by focus groups made up of the young ones who will enjoy the park in the future. Harold and Sheila would love the plan for Point to Point Park, and just like all of us, would exclaim 'WONDERFUL!' to the Butler family and their contribution to the Theodore Roosevelt Medora Foundation."

Other lead gifts to Point to Point Park include those from: Mike and Peggy Bullinger who made a lead gift in support of the "Little Bully Pulpit Mini Golf"; Steve and Gretchen Stenehjelm with First International Bank and Trust, who lead funding of the free "jumbo jumper"; James and Cynthia Jorgenson; and several other anonymous gifts who helped kick-start the project.

The new Point to Point Park is a \$7.3 million investment project and will be located on the eastern side of Medora. When complete, it will be a combination of paid and free attractions for the community and traveling public to enjoy.

Phases 1 and 2 of the project, including a revamped and reimagined "Little Bully Pulpit" mini-golf and "Manitou the Point to Point Zip Line Ride" are under construction now. When the Butler Foundation Challenge Grant is met, the entire Park can be constructed — with the goal set for that to commence in 2020. The completed Park will include a "Lazy Little Mo" river and pool, community splash pad, bathroom facilities, shade and play areas, stories of TR's time in Medora, and more.
