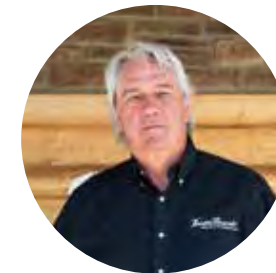

## RECORD FUNDRAISING YEAR

2024 was a major year in fundraising. A significant milestone was reached this year when the Theodore Roosevelt Medora Foundation surpassed \$100 million in gifts to TRMF since its inception in 1986. This year also saw a record number of gifts and donations to TRMF. In 2024, a total of \$14.3 million was raised, a new record for TRMF.

Medora is special. It has been a place of philanthropy and entrepreneurial spirit since April 1, 1883, the day the Marquis de Mores created the town. However, it was thanks to Harold Schafer that this town was able to grow into the tourist destination that it is today.

“None of this would be possible without the entrepreneurial spirit of Harold Schafer...” Levi Andrist, Board Chair, said. That spirit is felt today, with many of our major donors hailing from all four corners of North Dakota. The people of North Dakota want to keep Medora alive and well.

However, Medora is still growing and needs generous donors from across the country who want to see Medora survive and thrive. Here are our next projects:

**The Ranch at Bully Pulpit, Western Heritage, a new hotel, new trails at Point to Point Park, renovations to the town of Medora, additional Medora WISH events, and so much more. There is much work yet to be done in Medora.**

Director of Development Daniel Gannarelli says, “Why are we focusing on these projects and programs? It’s simple. When more people can stay overnight, more families and companies can celebrate life’s milestones in Medora, and the public can afford to visit us again and again – we create more *positive, life-changing experiences* for our guests. That’s what it’s all about.”

Our goals in 2025 are big, with new and large projects on the horizon, there has never been a better time to be a part of Medora.

# THE PRESIDENTIAL LODGE

## New Lodging Property Gifts of \$8.2 Million

Medora is a growing place. With the Theodore Roosevelt Presidential Library opening in 2026, Medora has been filling up with new employees, families, and guests. If you called our vacation center during our busy summer season, you may have encountered a problem: all our hotels and rooms were booked for the weekend.

The TRMF realized there was a need for a new lodging option in Medora. Discussions began in the early part of 2024. During the October 2024 board meeting, the board approved the hotel thanks to a major development gift.

An \$8 million gift was made by two anonymous donors. An additional anonymous gift of \$200,000 swiftly followed.

These incredible gifts will make it possible for a three-story, 100-room hotel to be built right next to the banks of the Little Missouri River on the west side of Medora.



Clarence Sitter, Chief Operating Officer, shares details about this property:

“Amenities that will be included in this new property are a breakfast area, an indoor pool, fitness room, and outdoor patio area. The hotel will be called the Presidential Lodge, and inside, the décor will pay homage to the history of the hotel’s location, which is only a few hundred feet where Theodore Roosevelt first stepped off the train to visit the Badlands. The hotel’s close proximity to hiking and biking trails with access to the Maah Daah Hey trail, the town of Medora, the entrance to the Theodore Roosevelt National Park, the *Medora Musical*, and the new Theodore Roosevelt Presidential Library will make it a new favorite for guests visiting Medora for years to come.”

The site is being prepared, with a potential open date in the fall of 2025, and the town of Medora is buzzing with excitement. Front Desk Manager Justin Morales was asked about this new lodging property:

“This new hotel will be a great addition to Medora. There was nothing worse than having to turn people away because we were too full at our other locations. This new hotel will create new opportunities for our guests and our staff.”

President Randy Hatzenbuehler follows up, “Medora has done more than survive, it has thrived!”

That is all thanks to the people across the world who care for Medora and want to see it thriving into the welcoming destination it is today.

Reflecting on the \$100 million worth of gifts, we decided to talk with some of our former board members about the past and future gifts given to Medora:

“Every gift tells a story. Ours is rooted in a deep love for Medora and the ND Badlands — a place that has brought us peace, joy, and wonder. We give so that future generations can experience that same magic,” Jim and Twylah Blotsky noted about their motivation to give.

“The Event Barn. I can tell you there will be two, if not three, Tschetter weddings there, and I only have three kids,” Greg Tschetter chuckled when asked what he was most excited about when it came to the future of Medora.

A final thank you to those who have given not just their monetary gifts but the gifts of their talents, time, and effort to ensure that Medora continues to survive and thrive. We are so excited for Medora to grow and reach more people for *positive, life-changing experiences*.

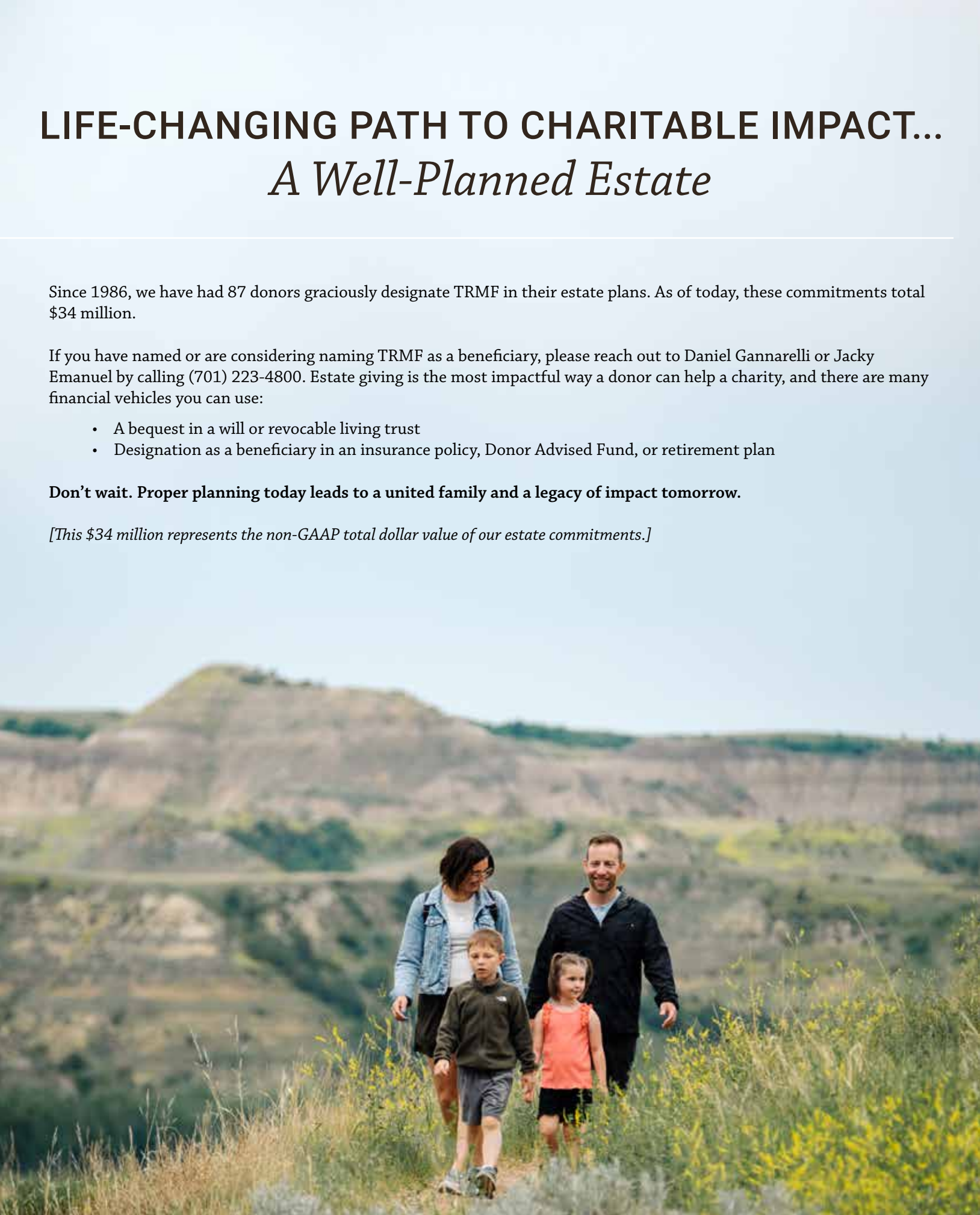

# TRAILS FOR GREATER ADVENTURE

Since the addition of the Point to Point Trail systems, a new avenue of adventure has opened in Medora. The Point to Point Trails are a hit with our guests, with many climbing the buttes for the views and uplifting experience of a hearty hike on the Strenuous Life Hike led by TR Reprisor, Joe Wiegand.

In the past few years, the trails have expanded thanks to the efforts of the Linda Pancratz Point to Point Trails Endowment, the Jim and Joanne Kack Point to Point Trails Endowment, the Recreational Trails Program grant from the North Dakota Parks & Recreation Department, and other donors. Linda Pancratz reflects on the importance of the trails:

"Our family was inspired by the opportunity to bring the liveliness of TR's spirited game, Point to Point, to Medora. The game had one rule: to go 'over, under, through...but never around an obstacle'. The trails are a fun way for families to play hard and experience 'the strenuous life' together as well as to connect hikers (young and old alike) to Theodore Roosevelt's love of the great outdoors!"

2025 will see further expansion of the trails to the eastern side of Medora. A large area northeast of the Medora Stables will include a few new trails that have been received with eager anticipation from guests and locals.





# The 2024 Bully Spirit Award

## BILL SORENSEN

Theodore Roosevelt, The Marquis de Mores, Harold Schafer. These three men have often been associated with the history and success of Medora. However, one person is missing from the list: Bill Sorensen.

Bill Sorensen has been a performer in Medora for almost 50 years, mayor of Bismarck, and the manager of Olympic Silver Medalist ND legend, Virgil Hill. Bill Sorensen is one of the most accomplished individuals in the state of North Dakota. In 2024, the Theodore Roosevelt Medora Foundation chose to honor Bill for his work, not only in Medora but in greater North Dakota.

Bill Sorensen has been in the limelight for most of his adult life. He has put on thousands of shows in Medora, where he has performed nearly every year since 1976. However, the strenuous life of a performer is not an easy task. Bill's family and doctor have been vocal about the struggles that Bill has faced.

"Oh, Bill's my hero," a misty-eyed Jim Sorensen reminisced on his memories with his brother and his love and passion in this lifetime. Bill has been one of the most inspirational figures in modern Medora history. From his struggles to his triumphs, he has inspired many other performers. One of those performers is Joe Wiegand, who was adamant that "Bill Sorensen makes my Teddy Roosevelt a better Teddy Roosevelt".

It was with great pleasure that the Theodore Roosevelt Medora Foundation was able to honor Bill at this year's Bully Spirit Award weekend. Many laughs were shared, and tears were shed as Bill's friends, family, and all of Medora came together to show appreciation and love for Bill Sorensen.

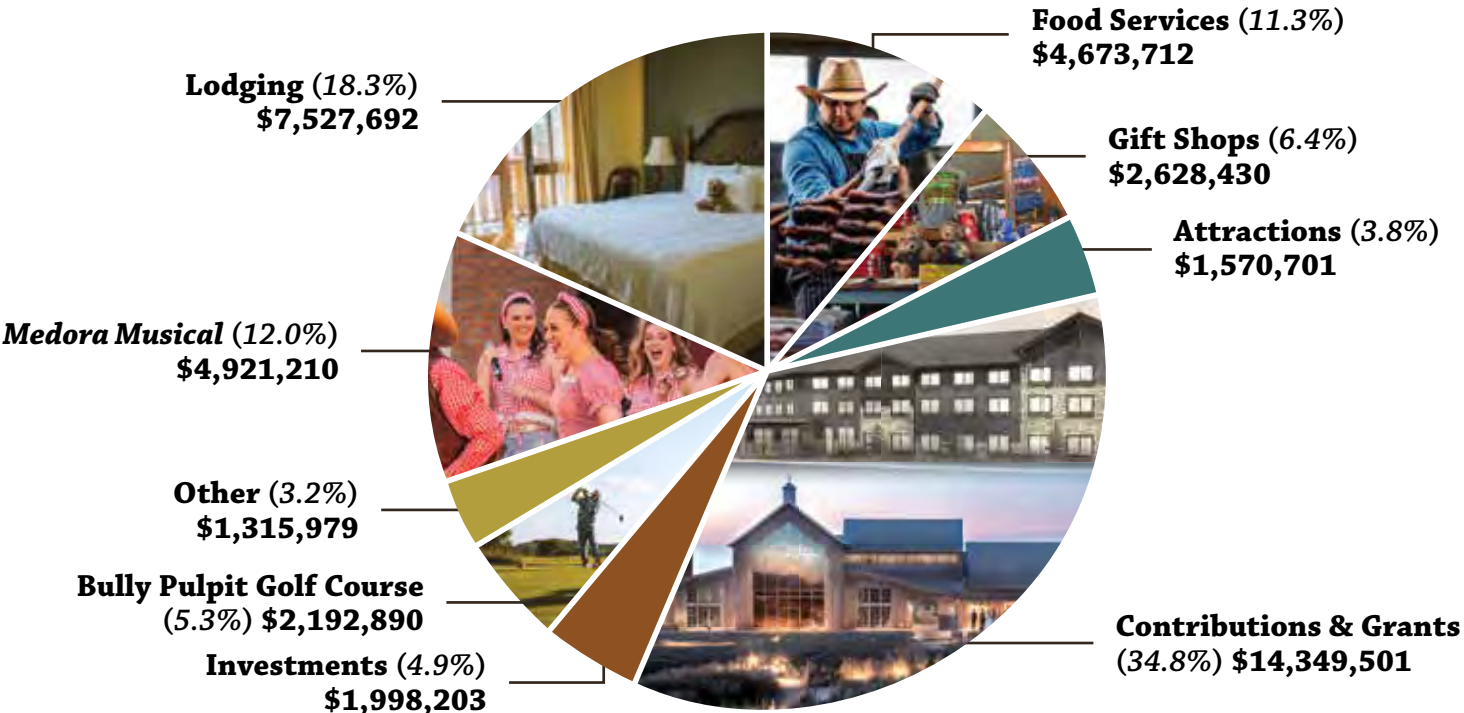
### Legacy Bully Pulpit Endowment

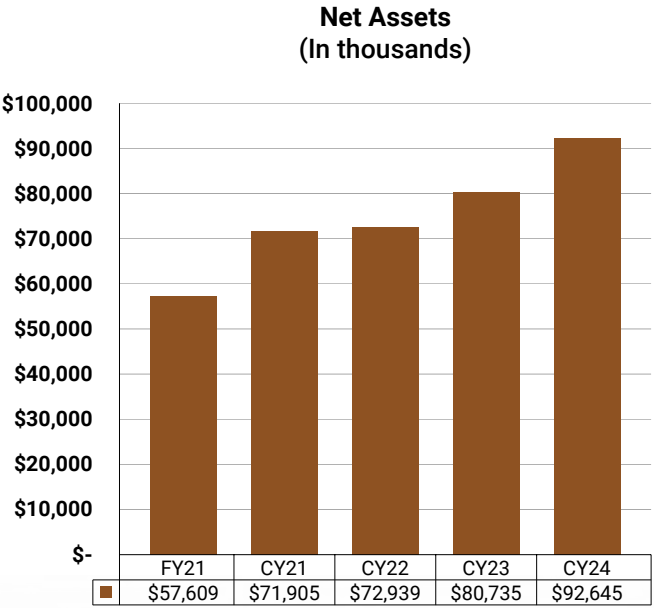
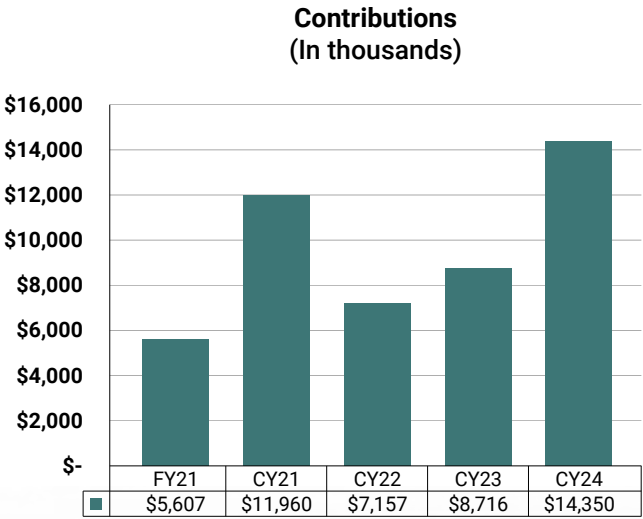

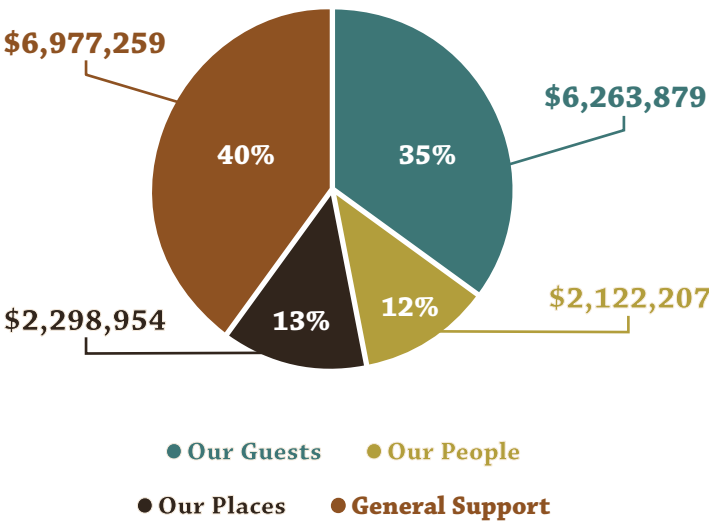

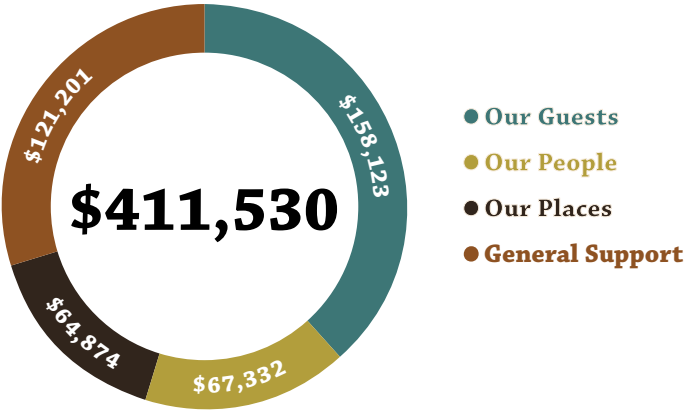

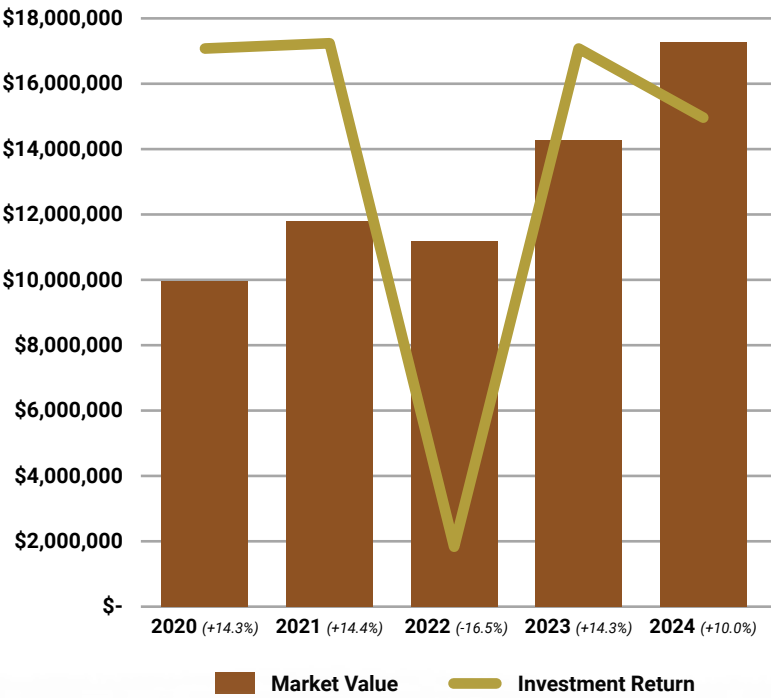
CURRENT ENDOWMENTS



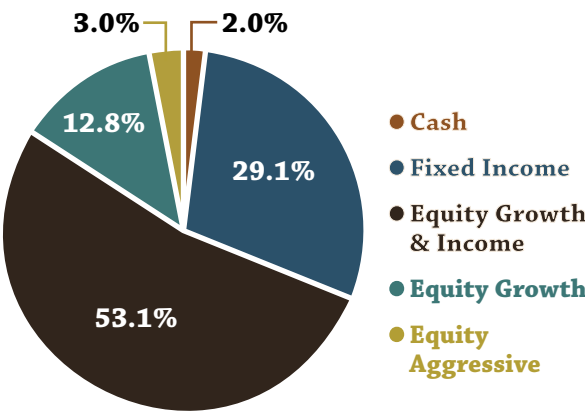
IMPACT DOLLARS USED IN 2024
